GI: Select the area, 95% of which the grapes are grown in (British Columbia is NOT allowed for an Icewine)

Varietal: Select the grape varietal. Only those with an asterisk are allowed

NOTE** If you will have several varieties from one grower, then each variety must be set up separately under that growers name, vineyard & WG number.

Example: grower “Z Vineyard” for a Chardonnay and same grower, “Z Vineyard” but a Riesling – this will be a new variety entry for the same Wine Grower.

Address Line 1 & 2: Enter and complete street address

Comments: If the address joins another location or township block you may add any those details here.

REGISTERING LATE HARVEST:

LATE HARVEST – is Registered the same way, using the IW-1 from - BUT you must **click the box** “Intended Late Harvest”

****NOTE**** if you have registered a variety for Icewine and then wish to change it later to Late Harvest you do this by clicking into the existing registration and then clicking the box “Intended Late Harvest”.

It is recommended that when in doubt always register as an Icewine, as this can be changed to a Late Harvest, BUT a Late Harvest CAN'T be changed to Icewine.
